A Breastfeeding Supporter is a mum who has breastfed her babies and had training so she can give support and information to other mums who want to breastfeed.

She can listen to you and talk with you on the phone; she may live near enough to visit you and may be able tell you about breastfeeding centres or local groups, where you can meet others for support and help.

When you call a Breastfeeding Supporter you will be speaking to another mum in her home.

The Breastfeeding Network is an independent voluntary organisation offering support and information to breastfeeding women and those involved in their care.

Money for our work comes from donations and small grants. To make sure we have nothing to gain from parents' choices we don't take money from companies connected with baby goods.

Breastfeeding Supporters don't get paid for their work on the phone or for visiting mums, but can claim expenses. If you would like to make a donation we can make a difference to more breastfeeding mothers.
